Prova Society was formed with a group of dedicated and like-minded people in Jhenidah district headed by Enamul Kabir. It is a non-profit, non-political and non-governmental voluntary organization. Prova Society has been working since its inception in 1994 in the field of health, education, water, sanitation, environment, climate change, human rights, agriculture and disaster for the upliftment of socio-economic status of poor and disadvantaged people of urban &rural areas of Bangladesh. It also implements the awareness raising program on prevention of women and child trafficking, HIV/AIDS prevention, early marriage, tobacco control and other issues. Prova Society gives special emphasis on women, children, youth and disabled development. Prova Society started to work in social development with a handful potential men and women committed to the causes of development of distressed people, particularly of disadvantaged men, women, children, youth and disabled. It has devoted &energetic professional staffs &volunteers for attaining sustainable development for the target group.



Management Structure

Chapter 15: Description of the activities carried out during 2019:

a. Assessment of Basic Literacy Project (64) district

With the support from Bureau of Non-Formal Education (BNFE) under Ministry of Primary and Mass Education, Government of Bangladesh, Prova Society conducted this project in Khulna and Barisal Division. Assessment were conducted from July 2019 to January 2020.

In order to achieve the goals of "Education for All (EFA) and target of National Plan of Action- ii (NPA- ii), The government of Bangladesh has decided to undertake a massive project titled "Basic Literacy Project (64 districts) with major objectives of providing Basic Literacy and life skills to 4.5 million illiterate adolescent and adults of 15-45 age group. Project Society has conducted the assessment of BLP (64 district) project in Khulna and Barisal division. Total 32 NGOs were engaged in implementing the BLP project in 32 upazilas. 20 NGOs were in Khulna division and 12 NGOs were in Barisal division. 561,491 learners were assessed. Out of the total learners, 355,706 learners were in Khulna division and 205,785 learners were in Barisal division. After learners evaluation it has been found that almost all of the learners 99.82% have passed. Only 0.18% has failed. But learners who have failed, concern teachers took classes again for two months and make them sure to read and write. Conducting after two months classes, our evaluation team took examination of failed students. Now the qualified learners are 100%. So the project fully has achieved the result.

b. Sewing Training, Suicide and Early Marriage Prevention

This project has implemented in Shailakupa upazila under Jhenaidah district of Bangladesh. With the support from Bangladesh NGO Foundation, we conducted the following activities:

- Baseline survey of target beneficiaries
- Sewing training
- Sewing machine distribution
- Arrange suicide prevention meeting
- Arrange early marriage prevention

c. Electric Consumer Survey

To update the consumer data in Rural Electrification Board, this project has been implementing in Madobdi upazila under Norsingdi distirct from August 2019. This project has been supported by EPTISA Services De Ingenieria S.L. The following activities have been carried out:

- Consumer data collection
- Data Validation
- Report Preparation

So far, we collected 50,000 data and provide report to concern authorities.

d. Tobacco Control Program

PROVA SOCIETY has been implementing on a Tobacco Control Program (TCP) in Jhenaidah districts. PROVA SOCIETY TCP is for development of Public Health to preventing disease relates to cigarette and tobacco products, offer a prolonging life and promoting health through organized efforts and informed choices of society, organizations, public and private, communities and individuals through promote implementation of rightly control over the tobacco and tobacco products usages. This project is being implemented by the support from Work for a Better Bangladesh Trust (WBBT) and own fund of Prova Society.

TCP's main activities are to activate Task Force Committees and Law enforcers, operate mobile courts at District Level and Upazila Level and Union Level, creating awareness among the management and authorities of public places and public transports, owners' and workers' associations of public transport, NGOs, CBOs, civil society and media people and community people. Community leaders, religious leaders, other influential persons are sensitized to actively support and assist in implementing the Tobacco Control Act 2005. Initiatives and efforts have been taken in sensitizing different stakeholders, creating awareness about harms of tobacco use and second hand smoking. The project has involved and activated all concerned stakeholders to play their roles in the effective manner for implementing Tobacco Control law putting special emphasis to make public places and public transports smoke-free. Efforts have also been taken to establish a system to sustain the activities by means of collaboration with local authorities comprising law enforcers, taskforces, mobile courts, local government, journalists, NGOs, civil society members and other formal and informal leaders.

e. Democratic Rights Education for Indigenous Women in Bangladesh.

We have arranged ten (10) women's educational seminar in the proposed project areas on Women Democratic Rights. In each village one seminar have organized and conducted successfully. Women attended the seminar enthusiastically. In each seminar 100 women were attended. Total 1000 women attended the seminar. In the seminar speaker were discussed about the women democratic rights, role of women in their family as well as socially decision making system. Women in the proposed project area got scopes to share their experience and refining their knowledge on women rights and their violation. They also learned about the legal aid services on violation of women rights from government and non-governmental organization and how to get the services. In time of open discussion women described their role, deprivations from sharing opinion in the family decision making process. Male member always dominate them and do not take their opinion. Women cannot take part in the local government election due to their family barrier. Union Parishad Chairman, commissioners and other influential persons were attend the seminar and delivered their speech.
